

## **Georges Affaki**

Prof. Dr. Georges Affaki is Associate Professor of law at the University of Paris II and admitted to practice before the Court of Appeal of Paris, France. He has served as chairman, panel and sole arbitrator under the rules of the leading arbitral institutions. He has also served as tribunal or party-appointed expert on international banking and finance, investment treaty claims, economic sanctions and comparative Arab laws.

He is Chairman-elect of ICC France Banking Commission and chairs the Legal Committee of the ICC Banking Commission that he founded. Prof. Affaki has held numerous leading positions within the ICC, including Vice-Chairman of the Banking Commission (2001-2012) and Chairman of the Task Force on Guarantees (2003-2013, now Honorary Chair) and of the Uniform Rules for Demand Guarantees drafting group (URDG 758). He chaired the revision of the ICC rules on dispute resolution by expertise (DOCDEX) which were unanimously adopted by the ICC Arbitration Commission and the ICC Banking Commission. He currently co-chairs the ICC Task Force on Financial Institutions and International Arbitration.

Prof. Affaki is a member of the Board of Governors of the UNIDROIT Foundation. He was previously managing director, member of the Executive Committee and Head of Legal at BNP Paribas CIB Legal.

Between 2011 and 2014, Prof. Affaki chaired the French Arbitration Committee working group on Arbitration in Banking and Financial Matters (report published on 19 May 2014). He acted as Rapporteur on International Law Association Resolution No. 3/2012 on international jurisdiction over foreign bank branches and chaired a Paris Europlace working group on Islamic Finance whose recommendations were presented in 2009 in a report titled Applicable Law and Dispute Resolution in Islamic Finance.

He is the author or editor of several books, including "Trade Finance", ITC Publishing (awarded the European Prize on Interdisciplinary Research); "Cross-border insolvency and conflict of jurisdictions", Bruylant; "Increasing Access to Credit – Reforming Secured Transaction Law", ITC Publ.; "The Guide to ICC Uniform Rules for Demand Guarantees" (with Sir Roy Goode), ICC Publ. No. 702; "Jurisdictional Choices" (with Horacio Grigera Naon), ICC Publ. No. 755, and over 60 articles and case notes on international banking, international arbitration and litigation, economic sanctions, cross-border insolvency and Islamic finance. He is regularly invited to chair or to speak in international conferences on those topics.

Prof. Affaki is fluent in Arabic, English and French.

He holds trustee positions in a number of non-profit organisations and is actively engaged in community projects.

## Yonov Frederick Agah

Yonov Frederick Agah was appointed as Nigeria's Ambassador to the WTO in 2005. In that capacity, he served as the Alternate Chief Negotiator for the Doha Round and Head of Nigeria's Trade Office to the WTO in the Permanent Mission of Nigeria to the United Nations Office in Geneva. The Trade Office is responsible for Nigeria's participation in Geneva-based trade-related international organizations, particularly the UN Conference on Trade and Development, the World Intellectual Property Organisation, the International Trade Centre and the WTO.

Mr Agah served as Chair of the WTO's General Council in 2011. He was responsible for organizing the Eighth WTO Ministerial Conference, which was acknowledged to be successful despite the prevailing stalemate in the Doha Round. He has also served as Chair of the following WTO bodies: Dispute Settlement Body in 2010, the Council for Trade in Services in 2009, the Trade Policy Review Body in 2008, the Council for Trade-Related Aspects of Intellectual Property Rights in 2007, and the Council for Trade in Goods in 2006. He was also the Chair of the Council for TRIPS, Special Session, in 2013.

Mr Agah has previously worked as a lecturer at Kaduna Polytechnic, Kaduna (1979-81), senior features writer/circulation manager, Benue Printing and Publishing Corporation (1982-84), Sales Manager, Benue Bottling Company Limited (1984-87), Field Manager, UTC Nigeria PLC (1990-91), Deputy Director (multilateral) (1991-2001) and Director (external trade) (2002-05).

Mr Agah holds a Bachelor of Science and Master of Science in Economics from Ahmadu Bello University, Zaria, Nigeria. He obtained a Master of Business Administration and Doctor of Philosophy in Economics (International Trade) from the University of Jos, Nigeria, in 1989 and 2007 respectively. His doctoral dissertation was on "Trade Policy Reform and Economic Growth in Nigeria Since 1986". Mr Agah also obtained a Bachelor of Laws from the University of Abuja, Nigeria, in 2009. He has contributed to various books and journals.

### Philip Kucharski

Philip Kucharski is an international development professional with extensive senior-level experience in managing multi-cultural projects and networks. Previously Head of Business Development and Global Networks, Mr Kucharski returned to ICC on Jan 5<sup>th</sup> 2015 as COO in charge of the operational management of the organisation reporting to Secretary General John Danilovich. This new hands-on role brings a fresh approach to ICC's structural, operational and commercial development with a new global management team.

A firm believer in ICC's mission of peace through prosperity, Mr Kucharski has developed a close and collaborative relationship with ICC's global network of national committees and chambers of commerce and is actively involved in all aspects of ICC's international operations.

Formerly Market Director EMEA for The Economist Magazine and Director of International Press for the Presstalis Group, Mr Kucharski has more than 20 years' experience in building media brands, exploring new markets and managing international development projects.

Of British nationality, Philip is a fluent French speaker, a passionate golfer and a lover of history, music, cinema, international cuisine as well as being a dedicated internationalist.
